- Under this facility, Investor can have an option to discontinue his SIP temporarily for specific number of instalments. i.e. 3 instalments OR 6 instalments.
- Investor can opt for pause facility only twice during the tenure of particular SIP.
- A separate SIP Pause Form will need to be submitted for each SIP; in case of multiple SIPs in the same/different scheme & same/different folio.
- SIP Pause Facility, once registered, cannot be cancelled.
- The SIP shall continue from the subsequent instalment after the completion of Pause period automatically; & if the SIP tenure gets over during the Pause period then the SIP will get closed automatically.
- The AMC reserves the right to terminate this facility or modify the conditions of the SIP Pause facility at its discretion.
- Taurus Mutual Fund or the AMC - Taurus Asset Management Co. Ltd., its registrars and any other service providers shall not be responsible and liable for any damages / compensation for any loss or charges incurred by the investor arising out of delay or technical aspects of registering the Pause facility. - Investors can request for pause request for SIP amount INR500 and above in Taurus Tax Shield and for SIP amount INR 1000 and above under other schemes.
- In case of discrepancies in the information provided in the SIP Pause Form and the details registered with the AMC, the details registered with the AMC shall be considered for processing or in case of ambiguity in the SIP Pause Form, the AMC reserves the right to reject the SIP Pause Form
